Company Failure and Clear • Quarter of a Million. MANISTER, De. 17.—The final report of the receiver of the Manistes Sait and Lumber company has been made to the Clrcuit coort, and the receiver dis-charged. The report shows the secured recitors were paid up in full, and the masceurd received 3.5.7 cents on the dol-lar of their claims. At the meeting of the company's cred-tors at Grand Repids, last January, the receiver reported the liabilities at \$1,000.31, of which \$104,000.100 were secured. The assets were estimated at \$750,307 by James Dambed Detroit, near of the receivers.
