DETROIT'S G. A. R. BILL FAILS IN THE HOUSE

LANSING, May 6.—Representative Doyle of Chippewa, was the cause of a slight flurry in the house this morning.

After the reading of the bill, Representative DeLoach, a Republican from Eaton county, hurriedly presented a resolution for an amendment providing that the appropriation be used only for tents, straw and fuel to the Detroit and Grand Rapids regiments.

The amendment was withdrawn so that no such amendment coming from a Republican should appear upon the floor. The amendment was not withdrawn but was voted down.

The Democracy was placed in a very embarrassing position. Inasmuch as the Patron and agricultural classes had been the mainstay of the Democracy and the old veterans favor the measure it was a case of "between the devil and the deep blue sea."

LOST ON THE LAKES

The Schooner Atlanta Goes Down in Lake Superior

SAULT STE. MARIE, Mich., May 6.—It is the sad fate of the schooner Atlanta which was reported lost off White Fish Point.

The schooner Atlanta was a three-masted schooner. A telephone message to Eckerman, a station on the South Shore road, says that the boat foundered the crew, two high and all the men but two were drowned when the little boat capsized.

The accident was reported by a boat that sighted the schooner in distress Monday evening, about 20 miles above the point.

The Atlanta was a new boat and making her first trip of the second season. She was owned by C. E. Eastman and W. W. Stone, of Saginaw, and Charles E. Johnston, of Bay City. Her value was \$28,000.

The steamer Wilhelm was towing her to Ashland, and Captain Bennett, of that boat, remained at the scene of the disaster and is looking for the bodies of the crew.

Commodore C. A. Smith, of the schooner Atlanta, was reported to have been killed. Captain Frank L. Knowlton, of Saginaw; Capt. John Durell, of New York; and Capt. J. H. Deane, of Detroit, were on board.

The message gave no names, it is not yet known how many were on board. The schooner was carrying a cargo of lumber.
